Re: VPAA's Five Year Perspectives 2023 to 2027-28

Dear Patty,

The Committee on Educational Policy (CEP) has reviewed the VPAA's Five Year Perspectives 2023 to 2027-28. Our committee continues to note concern regarding new undergraduate programs and the constraints of classroom and co-curricular space on our campus.¹

In reviewing the Five Year Perspectives lists, our committee notes that with the Assembly of the <u>Academic Senate's approval of Revisions to Senate Regulation 610 and 630</u>, Creative Technologies will no longer be allowed to be 100% online. Additionally, we note that the list currently does not list any program other than Creative Technologies as a "1".

Moving forward, when new proposals are submitted to CEP, we request that departments and programs provide information and/or data regarding anticipated room requirements; how many new courses will be required and the frequency of offerings. In the past CEP has held that no new programs may be approved without clearly delineated new spaces. While this has not been a tenable position, we must re-state that our classroom issue remains a significant crisis, and has far reaching implications.
