The Committee on Educational Policy (CEP) has reviewed the VPAA's Five Year Perspectives 2024 to 2028-29.

Our committee looks forward to reviewing the possible establishments of Statistics and Middle East and North African Studies and found no issues specific to those proposed programs to raise at this time.

Our committee wants to reiterate that the campus classroom and co-curricular space issue remains a significant crisis, and has far-reaching implications. As we indicated in response to last year's Five Year Perspectives list, we ask for attention to these issues in new proposals for new undergraduate programs submitted to CEP; these proposals should include information and/or data regarding anticipated room requirements, how many new courses will be required, and the frequency of offerings.

We noted that the columns on the right of the spreadsheet are oriented toward resource, modality, and space issues. We recommend adding a column that says something to the effect of "Will the proposed program add to campus classroom and/or co-curricular space demands?" It might also be helpful to have a column for the quantity of new courses required.
