

**Committee on Educational Policy
Approved Off-Campus Study Programs**

This document clarifies the status of approved off-campus study programs in relation to the undergraduate senior residence requirement, outlined in [Regulation 10.1.3](#) of the Santa Cruz Division of the Academic Senate:

Description of In-residence Programs:

Cross-Campus or Simultaneous Enrollment with Other University of California Campus

Undergraduate students enrolled at UC Santa Cruz may enroll, without formal admission and without payment of additional university fees, in courses at another UC campus on a space-available basis at the discretion of the appropriate campus authorities on both campuses. Simultaneous enrollment refers to UC courses not offered through UC Online. Cross-Campus enrollment refers to UC courses offered through UC Online.

Currently registered students must meet all of the following requirements to be eligible to enroll in one class through the Cross-Campus and Simultaneous Enrollment Programs: completion of a minimum of 12 credits at UC Santa Cruz as a matriculated student, be in good academic standing, and demonstrate appropriate academic preparation as determined by the host campus. Full-time students must be enrolled in at least ten credits at UC Santa Cruz. University Part-Time students must be enrolled in at least five credits at UC Santa Cruz and may enroll in up to ten credits total.

UCDC:

The UCDC Program at the UC Washington Center in Washington, D.C., supervises and supports students who pursue internships and academic study in the nation's capital. Descriptions of Approved Off-Campus Study Programs (not considered "in residence," but may be used to meet the residence requirement as outlined in Regulation 10.1.3.D of the Santa Cruz Division of the Academic Senate):

Intersegmental Cross-Enrollment

This program permits a student who is currently enrolled in a California community college, California State University, or University of California campus, and who meets certain eligibility criteria, to enroll in one undergraduate course at another campus each term, on a space-available basis. (UC students may take another UC campus course through either the Simultaneous Enrollment or Cross-Campus enrollment, above. UCSC may students attend another UC campus for one quarter or semester through the Intercampus Visitor Program, below.) For more information, go to [Intersegmental Cross-Enrollment](#). Courses are typically posted as transfer credit. ROTC courses through cross-town agreement between San Jose State and Santa Clara University are included on the transcript, with a notation, and credits are included in the UC Santa Cruz GPA.

Domestic Exchange Programs

UC Santa Cruz has exchange programs with the University of New Hampshire (UNH) and the University of New Mexico (UNM). Both schools give students the opportunity for an educational experience in an entirely different environment. For more information, go to [Domestic Exchange Application](#). Courses are included on the transcript, with a notation, and credits are not included in the UC Santa Cruz GPA.

Education Abroad Program

The Education Abroad Program (EAP) offers undergraduate and graduate students the opportunity to study at more than 140 host universities and colleges in 34 countries as part of their regular UC academic program. Inter-campus Visitor Program

UCSC students may take advantage of educational opportunities at other campuses of the University of California through the Intercampus Visitor Program. This program enables students to take courses not available at Santa Cruz, to participate in special programs, or to study with distinguished faculty at other campuses. UC Center Sacramento

The University of California Center Sacramento advances UC's mission of teaching, research and public service with an integrated program to train future state leaders, to address challenging public-policy issues confronted by the nation and state, and to carry out the university's mandate to assist state government. As a subset of the Inter-campus Visitor Program with UC Davis, UCSC students spend a quarter in Sacramento taking courses and interning with students from the other UC campuses. NRS California Ecology and Conservation Course

California Ecology and Conservation brings together 27 students from across the UC system for seven weeks of intensive learning at NRS reserves. California Ecology and Conservation is an intensive program of study with a workload equivalent to four on-campus courses. For classes held in fall and spring, students will earn 19 quarter units or 15 semester units, and semester students will be required to enroll in an extra course for which they will complete an extra project. For classes held in summer, all students will receive 19 quarter units or 12.7 semester units. For more information, go to [California Ecology and Conservation](#). UC Santa Cruz - APRU Virtual Student Exchange Member Institutions (outside U.S.)

As a [member of APRU](#), UC Santa Cruz launched participation in the APRU Virtual Student Exchange (VSE) Program beginning in fall 2021.

The [Virtual Student Exchange \(VSE\)](#) Program provides UC Santa Cruz students with the opportunity to enroll in one online academic course offered by a participating APRU member institution, as a part of their full-time course load taken at UC Santa Cruz. In exchange, a limited number of students from APRU member universities will be invited to enroll in select online courses at UC Santa Cruz.
