Re: Faculty consultation regarding library space and removal of print materials

Dear Robert,

At the October 22nd UCOLASC meeting, members discussed a situation that began about two years ago at UC Santa Cruz, which more recently received renewed attention at other campuses via faculty from the Council of University of California Emeriti Associations (CUCEA). Evidently, some UCSC faculty felt they were not properly consulted or sufficiently made aware of plans to remove materials and repurpose space in the UCSC Science and Engineering Library. CUCEA has publicized this <u>widely</u> and the UCSC Academic Senate passed a <u>resolution</u> on this issue.

To get appraised of the current status of the situation, UCOLASC consulted with the UCSC faculty representative to UCOLASC and the UCSC University Librarian (UL). I also raised this issue at the November 6th meeting of the Systemwide Library and Scholarly Information Advisory Committee (SLASIAC) with the UCSC UL in attendance. What UCOLASC gathered was that in the summer 2016, the UL initiated the Science & Engineering Collection Project in support of the Envision UCSC Goal: Student Success. Documents detailing the history of this project including a task force report, timeline, an FAQ, and other information are all available <u>online</u>.

While the Science & Engineering Library renovation project moves forward as planned, UCOLASC believes there are lessons to be learned from this experience. We understand why those faculty members who have written about this might have concerns and why the experience at UCSC could serve as a cautionary tale. So, to that end UCOLASC requests that Academic Council consider making a statement re-emphasizing the importance of faculty consultation as well as clear and open communication from the library (on any campus) whenever decisions are made about the reallocation of space, and/or the removal of books, journals, and other materials.

As we all recognize, the transformation of libraries is happening everywhere in academia as more and more content becomes available online in digital formats, and space on campuses becomes a premium. Keeping faculty involved in these decision-making processes is imperative.

We thank you, and the other members of Academic Council for your consideration of our request. Please let me know if you have any questions or need additional information.
