Chair's Announcements

The May 30 Senate Meeting deadlines were provided to COT. The group discussed whether any legislation should be considered. The question was raised as to whether a change in the professor of the year award nomination process would require legislation. The Senate analyst will make an inquiry regarding this. This will be a topic for future consideration.

COT considered the names of people who wish to visit the Committee this spring and others that the Chair wonders if they group would like to invite. COT does want to invite the ITC representative to discuss a change to WebCT. The Disability Resource Center representative will not be invited unless there would be added value by input from COT and unless there is time on agendas later this quarter. The Committee would like to invite the Committee on Educational Policy Chair Jaye Padgett to discuss the future of the writing-intensive requirement.

In considering who to invite this spring, the Committee discussed the status of the on-line evaluation project, specifically the pilot that VPDUE Ladusaw was asked to move forward with. Director Harris-Barnett reminded the group that the pilot was initially envisioned to make use of Irvine's software and that this cannot happen. Thus, the pilot is a much bigger effort because it lacks software presently. Director Harris-Barnett will check in with VPDUE Ladusaw to follow up on progress toward the pilot. At this time the group sees no need to meet with VPITS Merkeley on this topic.

Member Karplus updated the Committee on the meeting of the Committee on Computing and Telecommunication (CCT) with he attended as COT's representative. The topic of the meetings was whether or not to require laptops for undergraduates. Pedagogy was discussed. Financial aid issues were discussed. The future of instructional computer labs was discussed. These labs would not be eliminated. Equipment cost savings would go to other things for those labs, such as specialized printers. Extra laptops would be available.

It was noted that some private and public universities require them. Some of these other universities work with faculty to find ways to incorporate the use of laptops into the classroom so that students would clearly see the value of them in class. No particular type or brand of laptop would be required. ITC/CCT is talking to Apple and Dell regarding reduced cost contracts. CCT will circulate a report for senate committee input in the near future.
