Member's Items
Chair Rodriguez provided an update on the systemwide UCPB meeting of February 2, 2016. He reported that the Retirement Options Task Force Report was discussed.

## Off Cycle Recruitment Presidential Postdoctoral Fellow: BSOE

The Baskin School of Engineering requested authorization for an off-cycle recruitment for the hire of a Presidential Postdoctoral Fellow. The committee reviewed the request and will forward its recommendation to the CP/EVC.

## 3+1+1 Guidelines

Senior International Officer Joel Ferguson requested Senate review of guidelines he developed for 3+1+1 programs, which are intended for International students who complete three years at their institution abroad, one year as limited status students at UCSC (with bachelor's conferral from their institution abroad), and one year as a Master's student (with master's conferral from UCSC). These guidelines are intended for departments who are seeking to propose such pipelines to the master's degree programs for International students.

The committee noted that the guidelines could potentially create a pipeline for attracting qualified international students to the campus, and viewed the $3+1+1$ pathway as a mechanism for building relationships with overseas institutions. Concerns centered around the logistics of the program, and in particular, with the Memorandum of Understanding as written, which member noted could place undue burdens on participating departments. These concerns underscored the committee's recommendation for careful wording and the importance of establishing a fully staffed international office to handle these types of collaborations.

## Council of Provosts Core Proposal

The committee continued its deliberation of the Council of Provosts proposal for revising college core courses. After some deliberation, the committee decided to continue discussion of this item at the next committee meeting.
