#### **Members Items**

VPDGS Kletzer announced that she would like to have the Council take up the question of what the role of the GRE is, or should be, in the Cota Robles selection process, particularly in a context where some departments are choosing to make the GRE optional. Members agreed to bring this issue for discussion at the next Council meeting.

VPDGS Kletzer informed members that Emory University has increased its stipend to 31k from 24k (plus fee remission), highlighting the issue of admissions competitiveness.

## Revised Proposal for M.S. in Human Computer Interaction (HCI) (PDST)

The Council reviewed the revised proposal to establish an M.S. degree in Human Computer Interaction (HCI) proposed by the Computational Media Department. The program is proposed as a professional degree supplemental tuition (PDST) program. Upon review, the Council decided to seek consultation with CM Chair Jim Whitehead and CM Professor Sri Kurniawan, in order to address questions and issues raised during review of the proposed program proposal.

### **Theater Arts Fifth Year Certificate Discontinuance**

Graduate Council reviewed the proposal to discontinue the Theater Arts Certificate. The proposal was intended for discontinuance after launch of the Theater Arts M.A., but due to an oversight, had not been formally proposed for discontinuance. Graduate Council approved discontinuance of the Theater Arts certificate.

#### **Proactive Agenda: Graduate Growth**

GC continued its discussion of graduate growth and strengthening graduate programs within the context of the campus Strategic Academic Plan (SAP). Members further discussed the planned subcommittees on 1) graduate growth and 2) graduate student experience.

Linguistics

With member Anand recused, the Council discussed the documents pertaining to the external review of the Linguistics Department. The Council noted that the external review committee (ERC) commended the department for its overall excellence in training and placing students in post-graduate positions. The Council also raised a number of issues to be addressed in the closure meeting, including in the following areas: increasing the size and diversity of the applicant pool, staffing, space needs, graduate student funding, non-course opportunities for methods training, and cross-divisional collaborations.
